

# VTP461 ATV, UTV and Bikes

## DESCRIPTION

This two-day short course covers a selection of the following;

- Operate side-by-side utility vehicles; **OR**
- Operate quad bikes; **OR**
- Operate two-wheeled motorbikes

You will conduct pre- and post-operational checks; operate vehicles in a safe, efficient, and controlled manner over various terrain; load, unload, and secure a vehicle and perform minor maintenance and fault-finding.

This short course applies to individuals who operate utility vehicles and bikes to undertake routine work under general supervision, with limited autonomy and accountability.

## ELIGIBILITY/ENTRY REQUIREMENTS

To ensure you have the right skills and support to succeed in your course, a Language, Literacy, and Numeracy (LL&N) evaluation helps identify any areas where you may need additional support to help you achieve your goals.

To enter VTP461 ATV, UTV, and Bikes, candidates are required to be aged 16 years or above.
