This qualification aligns to Remote Pilot Licensing requirements described in Civil Aviation Safety Regulation (CASR) Part 101 - Unmanned aircraft and rockets and Part 101 Manual of Standards.

ELIGIBILITY/ENTRY REQUIREMENTS

To gain entry into AVI30419 Certificate III in Aviation (Remote Pilot), candidates are required to:

• demonstrate a solid level 2 or emerging level 3 language, literacy and numeracy against the ACSF to undertake this course.

To ensure you have the right skills and support to succeed in your course, a Language, Literacy, and Numeracy (LL&N) evaluation helps identify any areas where you may need additional support to help you achieve your goals.
