PURPOSE

As a member of CDU's alumni community, we want to make sure you stay connected to both your university and to lifelong learning opportunities.

As a CDU graduate, you have access to a range of benefits and opportunities, and in recognition of the value of continuation, we offer CDU Alumni a 10% discount on tuition fees for full fee-paying postgraduate courses.

The CDU Alumni Postgraduate Discount will be offered to eligible students commencing from Semester 1, 2025 onwards in an eligible postgraduate course. The terms, conditions, and eligibility requirements listed below apply to all recipients of the CDU Alumni Postgraduate Discount.

ELIGIBILITY CRITERIA

- 1) The CDU Alumni Postgraduate Discount is awarded at the discretion of the University to Alumni who are applying for full fee-paying postgraduate courses. The eligible courses for 2025 are listed in the appendix below.
- 2) You are classified as CDU Alumni if you have graduated with an award course from CDU or its antecedent institutions. Award courses at CDU include:
 - o Certificate I through to a Diploma (Vocational Education or CDU TAFE)
 - o Bachelor degrees
 - o Bachelor degrees (Honours)
 - o Graduate Certificates
 - o Graduate Diplomas
 - Masters degrees
 - o Higher degrees by research (HDR)
- The CDU Alumni Postgraduate Discount is only available for Australian or New Zealand Citizens, or those who hold Permanent Residency status in Australia.
- 4) The CDU Alumni Postgraduate Discount is not available to those who are in a:
 - o Commonwealth Supported Place
 - o CDU Course being delivered offshore
 - Those studying at CDU for one or two sessions as an Exchange or Study Abroad student
- 5) The CDU Alumni Postgraduate Discount is only available for students commencing study from Semester 1, 2025. You will not be considered eligible if you have previously enrolled in the same postgraduate award course

Scholarship terms and conditions

TERMS AND CONDITIONS AND ONGOING ELIGIBILITY

- The CDU Alumni Postgraduate Discount cannot be used in conjunction with any other CDU tuition fee discount.
- 2) The discount is non-transferable, cannot be redeemed for cash or any other benefit, and applies exclusively to tuition fees for the eligible course.
- 3) The CDU Alumni Postgraduate Discount is valid for the entire duration of the course, provided all conditions of the scholarship are met.
- 4) The discount can only be applied to the recipient's first enrolment in a course and cannot be applied to any future applications for the same course.
- 5) The discount cannot be applied to any units undertaken with a partner institution or organisation.
- 6) The recipient must notify the scholarships team by emailing scholarships@cdu.edu.au if any of the following circumstances arise:
 - a) The recipient discontinues their studies, or
 - b) The recipient defers or is approved for a leave of absence, or
 - c) The recipient changes their course of study, or
 - d) Any other circumstances that may affect the recipient's eligibility for the discount.
- 7) The CDU Alumni Postgraduate Discount remains valid whilst the recipient:
 - a) remains enrolled on a part-time or full-time basis in the eligible postgraduate award course on a Full-fee-paying basis
- 8) The CDU Alumni Postgraduate Discount will be terminated if the recipient:
 - a) fails to fulfill the ongoing eligibility requirements, such as:
 - i. Graduates from their nominated course; or
 - ii. cancels their enrolment at CDU; or

- iii. has their enrolment cancelled at CDU; or
- iv. the recipient ceases to be enrolled in the approved eligible course, or
- b) breaches the terms and conditions of the discount; or
- c) is found by the University to have breached the <u>Code of Conduct Students</u> or any other CDU policies.
- d) has provided false, inaccurate, incomplete or misleading information to obtain the discount
- 9) If the discount is terminated, the recipient will be notified, and an invoice for the full tuition fee may be issued. Appeals can be made through the University's complaints and appeals process.

The scheme will operate under and in terms of CDU's Common Course Rules, including but not limited to the Enrolment Policy, Scholarship Policy, Admissions Policy, Domestic Student Fee Policy, and Higher Education Academic Progression Policy.

CDU reserves the right to amend these terms and conditions or withdraw the scholarship scheme at its discretion and without prior notice. However, students already enrolled and paying tuition under this scheme will continue to benefit for the duration of their eligible programme, provided they meet the scheme's terms.
